

## **ADDITIONAL TERMS FOR SIMONETTE:**

1. Notification must be made by completing an Open Road Use Form on Keyera's Simonette Road website. Detailed information regarding company name, contact and usage must be provided within the form.
2. No later than **twenty-four (24) hours** prior to project completion, the Grantee must contact the Grantor's Field Representative. The Grantor's Field Representative will inspect the Road to determine if any excessive damages have been caused as a result of the Grantee's project. If the Grantor determines that damages have been caused, Grantor may bill the Grantee for repairs to the Road.
3. The Grantee shall not park or store any vehicles or equipment on the Grantor's roads at any time.
4. Grantee's vehicles must carry highway flares or high visibility reflectors while travelling on Grantor's Road. These must be used in the event of a breakdown or emergency.
5. Alcohol and drug use is prohibited for all drivers as regulated under the Criminal Code of Canada.
6. Under no circumstances shall tracked equipment be permitted on bridges on Grantor's Road. Tracked equipment must be hauled across bridges, unless otherwise approved by Keyera's field management.
7. The standard weight and load size (height/width) restrictions imposed by Alberta Transportation and Utilities apply to all of Grantor's Road except where written permission from Grantor permits otherwise. Written requests for permission to exceed the standard weight and load size is possible; however, Grantor is not obligated to approve any such request.
8. Grantee shall not use the Road during road closures with vehicles over one (1) tonne. Grantee must adhere to all road closures.
9. All loads over 16 feet wide require possible road closure and must have extra field approval prior to moving any loads.
10. Grantee shall comply with road limits, speed limits and partial or total road bans imposed daily by Grantor. Daily road ban restrictions for vehicles over one (1) tonne: **6:00 a.m. to 7:00 a.m.** and **5:00 p.m. to 6:00 p.m.**
11. There are weight restrictions on the bridges. All bridge weight limits must be adhered to. If Grantee has a load that exceeds a bridge's load limit, Grantee will then be responsible for all engineering of bridges to ensure integrity and safety of bridge or bridges
